## Qualification, Process, and Capital Assessment

Qualifications & Process: A candidate for membership is sponsored by a member of the Club or its management staff, has reached the age of 21 years; and has a baccalaureate or higher degree from an accredited college or university with not less than 2 years of experience in applied practice; or have not less than 6 years of experience of responsible character in their professional field of expertise. Candidates, who submit a completed membership application and credit card authorization form to the Club, will be granted Provisional Membership status (allowing for activity at the Club prior to review and approval by both the Membership Committee and Board of Directors at their regular meetings). Upon Board Approval, a house charge account will be activated in the member's name and membership card will be provided.
